EACH YEAR WE RECEIVE HUNDREDS OF APPLICATIONS FROM YOUNG MAINERS WITH A PASSION FOR THE TRADES AND WORKING WITH THEIR HANDS. THE AVERAGE AGE OF MAINE'S TRADE WORKER IS RISING AND TO SEE THIS SURGE IN YOUNG PEOPLE ENTERING THE TRADES IS EXACTLY WHAT WE NEED TO REINVIGORATE THE WORKFORCE IN MAINE. THE FOUNDATION HAS PROUDLY REMOVED THE BARRIERS FOR MANY YOUNG MAINERS WITH THE PURCHASE OF TOOLS, GAS TO GET TO CLASS, HOUSING WHILE THEY COMPLETE THEIR PROGRAMS AND TUITION. RECIPIENTS OF A SCHOLARSHIP CAN SUBMIT RECEIPTS FOR REIMBURSEMENT OR THEY CAN SUBMIT THEIR 2ND SEMESTER TRANSCRIPT AND THE FOUNDATION WILL SEND A CHECK DIRECTLY TO THEIR SCHOOL.
